### L2 CREDIT EXEMPTION AND RECOGNITION OF PRIOR LEARNING

### **Recognition of Prior Learning**

- 2.1. RPL is considered in terms of the UFH RPL Policy
- 2.2. RPL may be used to grant exemption from modules that contribute towards a particular qualification or for giving advanced standing in specific programmes through exemption from modules at lower levels of the qualification programme.
- 2.3. RPL cannot be used to exempt an individual from more than 50% of the modules required for any qualification.

### **Credit Recognition**

The recognition of previous credits shall always be subject to the provisions of **GR 3.6 and GR 3.9.** Credits previously obtained may be recognised as meeting some of the requirements for a qualification offered in the Faculty of Law. Generally, and subject to identified limits, the credits achieved towards one qualification may be recognised as meeting part of the requirements for another qualification. The Credits previously obtained may be from the same learning programme in another institution or another learning programme on the same or a different level of the NQF, the same or a different Sub-Framework of the NQF, in another department in the same institution, or a different institution.

A maximum of 50% of the credits of a completed qualification may be transferred from another qualification.

# L3 OFFERING OF MODULES AND ORDER IN WHICH STUDENTS MAY REGISTER FOR MODULES

- 3.1. The offering of elective modules shall always be subject to the provisions of **GR 4.7**. A list of electives that can, considering the academic staffing position, be offered in any particular year, will be made available to prospective students at registration. However, Faculty may still decide not to offer the module due to the insufficient number of interested students.
- 3.2. Unless designated as optional or elective modules, all modules offered in the Law programmes are compulsory and shall, subject to all the provisions of **GR 4**, be registered for at the appropriate level of study. However, students in the postgraduate streams shall be allowed a measure of flexibility in registering for law modules. Such students shall register in terms of guidelines and a timetable that will be made available on registration.
- 3.3. Unless special permission of the Faculty is sought and received, a full-time student pursuing the LLB degree shall only be entitled to register for modules not exceeding six (6) modules per semester or twelve (12) modules per year.

3.4. Unless special permission of the Faculty is sought and received, a part-time student enrolled for the LLB degree shall only be entitled to register for modules not exceeding four (4) modules per semester or eight (8) modules per year.

### L4 MODULE PARTICIPATION AND ASSESSMENT

- 4.1. The modes and procedures of formative and summative assessment, awarding of a qualification *cum laude*, supplementary assessment, reassessment and special examinations for students, shall be as prescribed respectively by General Rules 5, 6, 7, 8, and 9. Details of all assessments that take place outside the examination room shall be communicated to students in the module-learning guide for the module concerned, or as otherwise determined by the Dean.
- 4.2. Students shall be entitled to remarking and scrutiny of examination scripts, as provided for in **GR10**.

### **L5 DUE PERFORMANCE REQUIREMENT**

- 5.1. **Class attendance** is compulsory for all law modules. Accordingly, attendance registers shall be circulated in class and must be completed by students. A student's class attendance record shall be considered for considering condonations of final marks and any other discretionary student matters.
  - Subject to such additional requirement(s) as may be set out in the General Rules, a student may be excluded from writing the final examination in a module if s/he has not obtained:
- 5.2. Attendance of all tutorials is **compulsory**.
- 5.3. 100% participation in mandatory tests and assignments.

### **L6 REQUIREMENT OF EXAMINATION SUBMINIMUM**

Notwithstanding the provisions of **GR 6.10**, a student shall only be credited with a pass in a module if s/he obtained a minimum of 40 percent in the degree or supplementary examination.

A student who has been unsuccessful in obtaining the examination sub-minimum mark of 40 in the degree examination shall be entitled to a second chance at obtaining the said subminimum mark (through the supplementary examination) provided s/he obtained a minimum final mark of 45.

### L7 REQUIREMENT OF EXAMINATION ENTRANCE (DUE PERFORMANCE) SUBMINIMUM

A student shall not be eligible to write the degree or supplementary examination in any module in which s/he is properly registered unless s/he has obtained a minimum semester (DP) mark of 40% in the module. To avoid doubt, this rule shall not apply to a student who is registered for a module under **GR 6.9** or under any other institutional rule that exempts her/him from the requirement of a semester (DP) mark.

### **L8 COMPLETION OF CURRICULUM**

- 8.1. A student in the final year of study shall complete not less than 144 credits in modules at NQF Level 8 and NQF Level 7 (final year of study).
- 8.2. A student may, subject to the approval of Senate on the recommendation of Faculty, obtain credit for non-law modules, other than those listed in the curriculum for the law programme.

### **L9 GENERAL**

- General Rules **H1-H4** shall apply *mutatis mutandis* to all Honours qualification and 9.1. Postgraduate diploma programmes in law.
- General Rules **M1-M9** shall apply *mutatis mutandis* to all Masters qualifications in law. General Rules **D1-D8** shall apply *mutatis mutandis* to all Doctoral qualifications in law. 9.2.

# IMPORTANT INFORMATION FOR ALL PROSPECTIVE STUDENTS FOR 2025

# UNDERGRADUATE QUALIFICATIONS ADMISSION REGULATIONS

### **HIGH SCHOOL LEAVERS/ FIRST TIME ENTERING STUDENTS**

- 1. Students must possess a National Senior Certificate (NSC) endorsed with admission to a bachelor's degree and must have achieved a minimum Admissions Points Score (APS) of 27 (with Mathematics) or 28 (with Mathematical Literacy).
- 2. The APS and the GES are based on the achievement rating of each subject as indicated above and are the sum of the achievement ratings of the seven school subjects, keeping in mind that the performance rating achieved for Life Orientation must be capped at 3.
- 3. Prospective students currently in Grade 12 will be considered for admission to study at the University based on a Grade Eleven Score (GES) that is calculated in the same way as the APS using the final achievement ratings of the Grade 11 subjects.
- 4. Any student who has been provisionally admitted on the Grade 11 results will have to satisfy the minimum admission requirements in Grade 12 for registration for the relevant qualification as laid down by the University.
- 5. The GES and the APS are calculated as follows:
  - The prescribed seven subjects are used for the calculation of the GES and APS.
  - b. The GES and the APS of an applicant are the sum of the achievement ratings of the NSC subjects of that applicant, subject to the achievement rating of Life Orientation (10 credits) being divided by two in the calculation of the GES and the APS.
  - c. If applicants included more than the minimum of three electives in their NSC, the four compulsories and the best three of the electives are used.
  - d. If an elective is compulsory for admission, this subject must be included in the calculation.

### **INTERNATIONAL STUDENTS**

The Committee of Principals has, with the approval of the Minister of Education, in terms of section 74 of the Higher Education Act (101 of 1997) read in conjunction with section 7(1)(a), (d) and (e) of the Universities Act (61 of 1955), prescribed standards and conditions for the endorsements of senior certificates and the issuing of certificates of exemption from the matriculation endorsement as set out in the Schedule.

### **TRANSFERRING STUDENTS**

- 1. An applicant for admission to study at the University of Fort Hare who is either:
  - a. registered student at another institution at the time of application; or
  - b. was previously registered at another institution or institutions and did not complete the programme enrolled for at that institution; or
  - c. has completed studies at another institution (where there is a possibility of articulation and/or credit recognition and transfer), but is not currently enrolled at a tertiary institution; or
  - d. was previously registered at UFH, then moved to another institution and wants to be readmitted is regarded as a "transfer student" and the following rules apply to such an applicant's admission.
- 2. A transferring student will be considered for admission based on:
  - a. an NSC or other equivalent recognized qualification or consideration in terms of the admission policy and programme specific entry requirements;
  - b. having completed a qualification at a tertiary institution with some equivalent subjects/modules passed, as well as complying with programme rules on admission;
  - c. previous academic performance.

In addition, a transfer student will be required to provide a certificate of good conduct and a certificate of financial good standing from the current or previous institution.

### **RETURNING STUDENTS**

- 1. A returning student is a student who, at the time of application for a degree programme:
  - a. is a registered student at UFH, and wants to change from one programme to another, or
  - b. was previously registered at UFH and did not complete the programme enrolled for, did not register to study for period exceeding one academic year and did not enrol at another tertiary institution, who is applying for readmission, or
  - c. has completed studies at UFH but is not currently enrolled or was not enrolled at another tertiary institution after graduation.
- 2. The following will be considered when considering the readmission of a returning student:
  - a. an NSC with bachelor's or diploma pass (whichever is applicable) or equivalent qualification with exemption; and
  - b. meeting the minimum faculty-specific programme and subject requirements at NSC or tertiary level; or
  - c. previous academic performance (should have a cumulative weighted average of at least 50% for the programme enrolled for).
  - d. Confirmation of certificate of good standing as well as good financial standing.
  - e. having applied and was granted leave of absence.

### RULES OF CONDUCT FOR LAW STUDENTS

The Faculty of Law requires that all students use their official UFH email designation for messages between users within the University. The use of official email accounts is imperative as important information is sent to your official UFH email account and will then be considered as received by the recipient (student's) email account, and thus, be deemed received by the student. The Blackboard system will also only deliver messages to the official email addresses of students. The Faculty and the UFH rules do not consider WhatsApp group correspondence to be an official communication medium. Any communication received via WhatsApp must be confirmed by UFH email.

The use of electronic communication results in a considerable volume of messages sent and received each day. Email is analogous to other forms of conversation as regulated by the Electronic Communication and Transactions Act 25 of 2002 and requires equivalent thought and sensitivity. Everyone must be aware of the risks of any email communication. The onus rests with the sender to consider the content of the email and the circumstances of the intended recipient. Therefore, the sender must respect the recipient's role and consider and must respect the parameters of the recipient's position. Directing emails to recipients who should not be included in the communication results in undue delays, embarrassment, and confusion.

The Faculty and the UFH require students to always adhere to appropriate email etiquette when communicating with Faculty, UFH officials, peers and third parties. Email etiquette is intended to maintain a respectful, appropriate, and professional tone in all electronic communication. Email etiquette is especially relevant for law students when communicating with the Faculty, peers and third parties. Law students must use every opportunity to prepare for their future endeavours. Students must regard every interaction and/or correspondence as an opportunity to improve their skills and as preparation for their future efforts. Please remember that email is different from texting and therefore has its own set of rules and standards.

Students are required to access and use their UFH email accounts daily and acknowledge receipt of emails directed for your attention, and/or take note of important information received. Students should respond to emails sent by the Faculty within 24 hours of receipt. Emails sent from private email accounts may be lost or rejected by the UFH server, and the Faculty is required to respond to official UFH email addresses only. You are further required to maintain your email account and delete any unnecessary emails received to ensure that your email account does not reach its limit, thereby rejecting new messages. Remember to install an automatic reply system advising that you will not respond during any period where you may be away or unable to respond to emails.

Please take note of competing pressures on people's time and energy. You should not expect an immediate reply to an email that was sent outside of regular working hours. Members of staff will attempt to answer all emails addressed to them as quickly as possible. Still, there can be no automatic assumption that replies to emails will occur as a necessary practice outside of working hours. Equally, emails containing a request, which results in an obligation and pressure to respond at short notice, should be avoided where possible, and timeous action should be taken to prevent creating unnecessary urgency.

### Students are specifically requested to:

- Peruse the Module Learning guide, previous emails and announcements from the lecturer, the General and Faculty Prospectus and other communication from the Faculty;
- Include a clear and direct subject line. Briefly state what your email is about, and do not leave the subject line blank;
- Not to write in capital/block letters;

- Avoid lengthy email exchanges and be sensitive to the tone in your email;
- Include your full names as registered in the University system, title, student number, and the
  Module name and code in your email. You must also include information detailing the issue
  you want to address, what you have done to resolve the matter (be proactive), and the
  preferred outcome you require.

NB: Please refer all your academic matters to responsible lecturers. You are urged to adhere to the lines of reporting. For example, in cases wherein the lecturer could not resolve your academic matter, you are required to refer the matter to the relevant HOD responsible for the Module. In doing so, include the necessary details of the case, appropriate documents and any previous emails between you and the lecturer.

- Use professional salutations (for example, Dear Prof, Dr, Adv, Mr, Ms, etc.); ensure that you refer to the recipient by the person's correct title.
- Proofread emails before sending them. Use a proper font style (UFH uses Arial or TNR) and make sure that the email is legible.
- Only include attachments that are readily assessable such as MSWord or PDF documents.
- Avoid replying to all if you receive an email addressed to you as part of a group unless a
  collective response is specifically required.
- Before forwarding emails to other parties, consider their options carefully and exercise particular caution and restraint in forwarding attachments considering the provisions of the Protection of Personal Information Act 4 of 2013. Remember that an email to you is sent for a specific purpose, and you should not extract/redact/quote from the email in social media where the content is not intended for broader distribution.

facts, lawful and unlawful acts.

**Teaching**: Expository lectures and class presentations.

Assessment: Continuous assessment through participation in class, tests,

assignments, essays, and a three-hour examination at the end of the

semester.

**Target**: First year LLB students. May however be taken by interested BA, B Com

Industrial Psychology and Business Economics students.

LPR 113 E Law of Persons

Group

**Purpose**: The Law of Persons concerns the totality of the legal rules and principles

which govern Legal Personality, and which determine Status and Capacity of Legal Persons under the South African Legal System. This intensive introductory course is designed to give you a competent

understanding of the General Principles of the Law of Persons and to develop your related academic and general legal skills in preparation for graduate research and/ or legal practice. The course emphasises both knowledge of relevant current Common law, Case law and Statutes, as well as the need to be able to creatively adapt and apply Persons principles and rules to novel practical situations arising in the context of our Constitutional Democracy.

Contents

Legal Personality, Status & Capacity. The Beginning and Ending of Legal Personality, Factors affecting status and capacity (Domicile, Age, Sex & Gender, Mental Illness, Intoxication, Insolvency, Prodigality). The law & the Dead.

Teaching

Participatory seminars, guest lectures, situated learning experiences (where feasible).

Assessment

: Continuous assessment consisting of Topic-specific theory tests/ tasks. Alternatively, Topic-specific theory tests/ tasks and a final internally moderated 3-hour examination.

Target Group

: LLB students, as well as students studying towards the BA (law) and B

Com (Law) degrees.

### **LEG 113 E**

### Legal Skills

### **Purpose**

: The Legal Skills module for first year LLB and Legal Studies students integrates foundational training in legal writing and research skills with learning "the law." It incorporates analysis, research, and writing skills training in connection with various fields of South African law. The aim is to ensure that first year law students experience the relationship between legal doctrine and skills as they exist in the study and practice of law. The module will also include a component on Introduction to Advocacy, which advances skills training in the context of a simulated lawsuit. Students learn the fundamentals of persuasive writing by preparing trial-level briefs as well as arguing case in a moot court setting/mock trial.

### Contents

Introduction and general background; Foundational Legal Skills; Computer Skills; Communication Skills; Legal Research Skills; Legal Writing Skills; Researching and Studying Law in a diverse World; Citing and Tracing Legislation; Reading of Court Cases; Advocacy skills.

### Teaching

: This course adopts a hybrid approach towards teaching and learning. This will take place through a variety of teaching methods. In terms of delivery, the course uses a blended learning approach to delivery and independent study. Content will be delivered through either physical contact classes or technology enhanced learning which will involve the use of the Blackboard virtual learning environment.

### Assessment:

Continuous assessment through participation in class and on Blackboard, through assignments and essays, class tests, and a 3-hour written examination at the end of the semester.

: It engages the concept *consortium omnis vitae*, the variable consequences of a civil marriage, alteration of the matrimonial property system, dissolution of marriages, grounds for divorce, patrimonial consequences of divorce, maintenance of spouses after divorce, the interests of the children of divorcing parents, civil unions and domestic violence, nature of the family law, legal rules, regulations, concepts and principles applicable to family.

Teaching:

Formal lectures, informal lectures and discussions, tutorials, written

assignments and tasks and class exercises.

Assessment:

Formative assessment by two (2) formal tests of equal weight plus a compulsory assignment / research paper. Formative assessment by a 3-hour paper internally moderated.

#### LIP 311 E

#### **Instruments of Payments**

The course augments the commercial and business law course offerings, introduces students to the laws governing digital currencies and to the specialised field of banking law, and is particularly relevant to those intending to work in these areas. It further develops skills in doctrinal analysis and statutory interpretation.

: The module introduces the law of negotiable instruments, cheques, bills of exchange and promissory notes, the banker-customer relationship and covers cheques, credit cards, stop orders, debit orders, travellers cheques, online banking, electronic fund transfer, unjustified enrichment, and digital currencies.

In this second half, students are introduced to the statutory rules, legal principles, jurisprudence and policy reasoning relating to, amongst others, corporate governance, directors' duties, business rescue, winding-up, and close corporations.

Governance and shareholders; governance and the board of directors; corporate governance; duties and liabilities of directors; the auditor, financial records and reporting; shareholder remedies and minority protection; enforcement and regulatory agencies; business rescue and compromises; winding-up; and close corporations.

#### LPS 322 E

#### Law of Succession and Administration of Estate

#### **Purpose**

: The purpose of the course is to equip students with a sound knowledge of the totality of the legal rules which control the transfer of those assets of the deceased which are subject to distribution among beneficiaries, or those assets of another over which the deceased had the power of disposal. The module is meant for learners studying for the legal profession (attorney/advocate) and for Bachelor of Commerce graduates, other participants in commerce and industry and corporate, public and business functionaries.

: INTRODUCTION: Overview; Basic Concepts; Sources; Ways in which Succession takes place; Requirements for Succession; Vesting & Enforcement of Right to Inherit; THE LAW OF INTESTATE SUCCESSION; Basic Concepts; Intestate Succession Act; Rules of Intestate Succession; Succession & Science; Customary Law of Succession; TESTATE SUCCESSION: Freedom of Testation; Testamentary Capacity and Capacity to sign as a witness; Formalities in the execution and amendment of wills; Invalid wills and revocation of wills; Capacity to inherit; The contents of wills; Joint / mutual wills, adiation/repudiation/election and massing of estates; Accrual (the *ius accrescendi*); Collation; Interpretation and rectification of wills;

Succession by contract (the *pactum successorium*); ADMINISTRATION OF ESTATES: Overview of the Administration Process; Key Role Players (the Master of the High Court, the Executor of a Deceased Estate, etc); Types / Catergories of Estates; Reporting the Estate; Methods of liquidation; Formalities of Liquidation and Distribution Account (L&D Account): Regulation 5 of Administration of Estates Act 66 of 1965; L&D Account: drafting of different accounts & consolidation; L&D Account: advertisement and inspection; Finalisation of the administration of the estate.

#### **Teaching**

This course adopts a hybrid approach towards teaching and learning. This will take place through a variety of teaching methods. In terms of delivery, the course uses a blended learning approach to delivery and independent study. Content will be delivered through either physical contact classes or technology enhanced learning which will involve the use of the Blackboard virtual learning environment.

#### LOI411E Law of Insolvency

**Purpose**: This module is a final year module designed for those involved with legal

aspects of the sequestration, administration and rehabilitation of insolvent estates: Legal practitioners, administrators, trustees, bankers and officials of the office of the masters of the High Courts of South Africa. It is intended to equip them with in-depth knowledge and

understanding of the processes involved in personal insolvency.

**Teaching**: Expository lectures, class participation, and take-home assignments

LAC 413 E Law Clinic Internship

**LAC 423 E** 

or

Purpose : Also known as the Clinical Legal Education Programme. This course

offers students their first opportunity of working with real clients and conducting actual litigation, under guidance of the attorneys and the Director of the UFH Legal Aid Clinic. This is done mainly through the delivery of legal services to the indigent, thereby promoting access to justice for them and fostering a commitment in the students to build a society based on democratic values, social justice and fundamental human rights. Students attend two lectures per week on practical subjects and also conduct ongoing cases on behalf of their clients. In addition, each student participates in a Mock Trial which is based on an

actual Legal Aid Clinic case and is argued before an actual Magistrate or Attorney. Practical Law strives to integrate theory and practice within the LLB curriculum by using clinical methodology for teaching students substantive and procedural law and skills

#### LFH 422 E Human Rights Law

Purpose : The course is intended to ground students with basic knowledge and

understanding of human rights; their philosophical foundation and historical development; norms and principles; and institutions built around them. This will be approached by emphasizing the theory and practice of human rights through a selection of documents, reports and scholarly publications on the most persistent debates and emerging

themes.

**Contents**: The foundation and history of human rights; problematic of definition and

areas of contestation; contemporary challenges; national promotion including mechanisms and procedures for protection; international and regional systems for promotion and protection; Human Rights and

International Humanitarian Law.

#### **LES 423 E**

#### **Social Security Law**

#### **Purpose**

: This module is designed to prepare Students to act as legal practitioners and advisers or policy analysts or administrators who may be called upon to provide legal or policy advice or support or manage matters relating to Social Security, and to provide practical solutions to maters concerned with social security law.

#### **Contents**

: Introduction: Concept of Social Security, Social Security Law & Sources of Security Law; Scope & Function of Social Security, Legislative & Theoretical Framework; Social Security Provision in South Africa; Claim Procedures; and Enforcement & Adjudication.

#### **Teaching**

: This course adopts a hybrid approach towards teaching and learning. This will take place through a variety of teaching methods. In terms of delivery, the course uses a blended learning approach to delivery and independent study. Content will be delivered through either physical contact classes or technology enhanced learning which will involve the use of the Blackboard virtual learning environment.

The syllabus includes, economics of competition, the scope of the Act, concurrent jurisdiction, extraterritorial application of the Act, horizontal restrictive practices, vertical restrictive practices, abuse of dominance mergers and acquisitions, exemption applications, corporate leniency policy, market inquiries, and enforcement of competition in digital markets.

Private competition law focuses on an overview of unlawful competition including Origins and legal basis for unlawful competition in South Africa, passing off, deception concerning one's own enterprise or performance, Misappropriation of the advertising, value, misappropriation of confidential trade information or trade secrets, misappropriation of a

rival's performance, disparaging allegations about a rival's enterprise (business), goods or services, harassment of a rival's customers, employees or suppliers, Instigating a boycott against a rival, grounds of justification: direct infringement of goodwill and competition rivalry in contravention of a statutory provisions, e.g. the Trade Marks Act.

**Teaching**: Lectures, individual and group class presentations, class problem

solving, independent learning, practical exercises, seminars, research

assignments and take-home assignments.

**Assessment**: Formative assessment through class participation, one assignment and

a class test; summative assessment through a three-hour externally

moderated examination.

**Target**: LLB students in their penultimate or final year of study.

#### LMS 413 E Security Regulations

Purpose : This module is designed to provide Students with knowledge of, and capacity to apply, the statutory provisions and common law principles governing the issue and distribution of securities as well as the conduct of the institutional and individual actors involved in the Securities

industry.

**Contents**: Background on Securities Markets; History, Objectives, Techniques and

Sources of Securities Regulation; Institutional Framework for Financial Services Regulation; The Prospectus Requirement; Regulation of Market Abuse: Insider Trading; Market Manipulation; and Deceptive Market Practices; Regulation of Takeovers; Collective Investment Schemes; Regulation of Securities Market Intermediaries; Current

Issues and Future Prospects.

**Teaching**: Expository lectures and class presentations.

**Assessment :** Continuous assessment through one class test and one assignment.

Summative assessment through one 3-hour, externally moderated,

examination.

**Target**: For LLB students in their penultimate or final year. May however be taken

**Group** by interested B Com/B Admin and M Com students.

#### LMI 413 E Intellectual Property Law

Purpose : This module will critically examine the legal rules and institutional

framework designed for the regulation and protection of intellectual property rights in South Africa with a view to understanding the creation, registration and enforcement of the various intellectual property rights such as patents, designs, copyrights, trademarks, geographical indications and indigenous knowledge. A key objective of this module is to identify how intellectual property and human rights relate and align within South Africa's constitutional imperatives. Understanding how intellectual property rights impact on development is important for a country such as South Africa which must incentivize creativity and innovation on the one hand and yet ensure that socio-economic rights such as access to affordable medicines; access to information and

educational materials are reflected in the manner in which intellectual property rights are conceived, interpreted and enforced.

#### Contents

: GENERAL INTRODUCTION: Definition, objectives & theories of intellectual property, Trade Related Aspects of Intellectual Property, Intellectual Property and Development, Intellectual Property and 4IR, Regional & International Intellectual Property Protection; PATENTS: Definition & Rationale for Patent Protection; Requirements for Patentability; Registration & its Effect; Exploitation of Licences; International & Regional Protection of Licences, Patent Revocation Infringement & Remedies; Patents and Access to Essential Medicine; TRADE MARKS: The Definition & Nature of Trade Marks, Registration of Trade Marks, Administration of Trade Marks, Trade-Mark Infringement & Remedies, Passing off; COPYRIGHT: Definition & nature of copyright, Requirements, Nature & Scope of Works Eligible for Copyright, Collective Administration of Copyright, Exceptions and Limitations, Copyright Infringement & Remedies, Copyright & Human Rights, Copyright Reforms in South Africa.

Part two covers carriage of goods by sea. Part three focuses on enforcement of maritime claims through the practice and procedure of

the Admiralty Court, including arrest, statutory action in rem, and classic maritime liens. Part four sketches on the maritime or marine related policies.

: MARITIME LAW: Introduction to Maritime Law; The Ship (Types, Ownership, Registration; Nationality, Management); Safety at Sea; Ship Wreck; Salvage, Towage & Pilotage; Maritime Casualties & Liabilities; Marine Insurance; CARRIAGE OF GOODS: Introduction to Carriage of Goods by Sea; INCOTERMS; Contract of Carriage at Common Law; Bills of Lading & Other Carriage documents; Charter-parties; Carriage Regimes (The Hague-Visby, Hamburg, & Rotterdam Rules); The SA Carriage of Goods by Sea Act; Cargo Claims; Defenses; and, Limitation of liability; ADMIRALTY JURISDICTION: Introduction to Admiralty Jurisdiction & Practice; Origins and Historical Development of Admiralty in South Africa; The maritime lien and the statutory right in rem; Modern South African Admiralty Regulation; Arrest & Attachment of Maritime Property; Judicial Sale and Establishment of the Fund; MARITIME REGULATION AND POLICY: The Role Players in Maritime Policy & Regulation; Ocean Economy and Management Policies; Comprehensive Maritime Transport Policy for South Africa; Transport Security (Piracy & ISPS Code); Maritime Safety Policies & Regulations; Port / Harbor Law (Port Regulation, Operation, Management and Personnel).

#### Teaching

This course adopts a hybrid approach towards teaching and learning. This will take place through a variety of teaching methods. In terms of delivery, the course uses a blended learning approach to delivery and independent study. between the cyber world and diverse areas such Contracts; Crime; Evidence; Privacy; Freedom of Expression; Intellectual Property; Domain Name Resolution: Data Protection; Access of Information; Telecommunication and Consumer related issues.

#### **Contents**

Introduction to Cyber Law and Legal Informatics; Electronic Contracts; Cyber Crime in South Africa; Legal aspects of Privacy and Freedom of expression on the Internet and social media platform; Electronic Intellectual property; Domain Name Resolution (UDRP / Domain Disputes); Data Protection and Access to Information; Taxation of Electronic Transaction; Electronic Evidence; Telecommunication Law; and, Consumer Protection

**Teaching** 

Expository lectures, class presentations, seminars; draft of legal opinions, research and writing of assignments.

**Assessment** 

: Students are required to do all the assessments, both formative and summative. Students' group work and individual research-based assignments will be assessed. The test and examination are assessed summatively with feedback and comments on the test constituting formative assessment.

Target Group

: LLB students.

#### LPD 413 E

#### Media Law

#### **Purpose**

Media Law is an elective LL B module offered in the second semester. It carries 12 credits which constitute 120 notional hours of work. These notional hours include lectures, research for, and writing, the assignment, self-study as well as preparation for the test and examination. There are no tutorials in this course but additional classes, whether called tutorials or by any other name, may be held on an ad hoc basis

This module is designed to prepare you to excel as a legal practitioner, adviser or compliance officer who may frequently be called upon to provide legal advice and tackle matters relating to media issues. It will equip learners with a sound knowledge of the theory and practice of media law and how this module complements other courses in practice. This module will afford learners an opportunity to comprehend the legal framework within which communication takes place. In addition, learners will be exposed to, inter alia, the theoretical and constitutional background to media law, the rights which uphold freedom of expression as well as legal limitation to such freedom and the laws regulating public communication such as the press, broadcasting, entertainment and telecommunications.

#### **Contents**

1 Introduction and general remarks on the course in Media Law; 2 Theoretical background to and principles underlying communications law; 3 Constitutional right to freedom of expression / communication; 4 Constitutional rights which strengthen and complement freedom of expression / communication; 5 Constitutional limitations to freedom of expression / communication; 6 Statutes that limit freedom of expression / communication; 7 Censorship — control of the publication and

dissemination of information; 8 Advertising and the Law; 9 Strict liability of the media in the case of defamation and the invasion of privacy; 10 Laws regulating the press, broadcasting, telecommunications and entertainment; 11 Court Proceedings; and 12 Copyright.

**Teaching** 

Expository and interactive lectures; a semester assignment; a class test; group activity, role acting and presentations (as may be practicable); and student consultations. Teaching is now ONLINE via Blackboard (2020 - 2022)

Assessment:

Continuous assessment as well as an exam which is externally moderated. You will be assessed through a series of tasks which will go into your portfolio. The portfolio will be marked in May. #### LMX 423 E Tax Law

#### **Purpose**

: General introduction to SA tax system and various types of tax; general (principles of income tax law, overview of taxation of natural persons and juristic persons, deductions, tax avoidance, overview of other forms of taxation, VAT, capital gains tax, transfer duty.

#### **Teaching**

: Lectures, self-study, research assignments with feedback from lecturer, and practical exercises.

#### Assessment

: Assessment through assigned exercises and class tests. Summative assessment through an examination externally moderated.

**Contents**: Bio-ethics, Health Legislation & case law, Health Professions, Traditional

The course emphasises both knowledge of relevant current Common law, Case law and Statutes, as well as the need to be able to creatively adapt and apply Delict principles and rules to novel practical

situations arising in the context of our Constitutional Democracy.

**Teaching**: Participatory, expert-led seminars and guest lectures, possible

independent student research. Reports or presentations, self-study, problem-solving tasks, situated/ authentic field-learning experience

(where feasible).

**Assessment**: Continuous Assessment consisting of Topic-specific theory tests/ tasks.

Alternatively, Topic-specific theory tests/ tasks and a final internally-

moderated 3-hour examination.

**Target**: LLB students.

LCP 423 E Advanced Criminal Law and Procedure

**Purpose**: This is an elective module for the LLB degree. The purpose is to

empower students with an understanding and application of certain advanced aspects of criminal law and procedure with specific reference to organised crime, child justice law and specific type of witnesses and

evidentiary duties within the criminal justice system.

**Contents**: Organised Crime & Proceeds of Crime: Racketeering, Money

Laundering, Civil recovery of property (Preservation-of-property orders and forfeiture), Bribery & Corruption; Child Justice & the Law; International Criminal Law: Rome Statute of the International Criminal Court (Statute), Elements Crime, Rules of Procedure & Evidence (Rules), Regulations of the Court; Transnational Criminal Law; Selected

& Miscellaneous Aspects of Criminal Procedure: Entrapments, Hostile witnesses, Section 204 Witnesses, Hearsay evidence, Sections 3, 15 and 16 of Criminal Law (Sexual Offences and Related Matters) Amendment Act 32 of 2007; Sentencing.

#### Teaching

This course adopts a hybrid approach towards teaching and learning. This will take place through a variety of teaching methods. In terms of delivery, the course uses a blended learning approach to delivery and independent study. Content will be delivered through either physical contact classes or technology enhanced learning which will involve the use of the Blackboard virtual learning environment.

#### **Assessment:**

Students are required to do all the assessments, both formative and summative. Different methods of assessments will be used in this module, including test; group work; moot courts and, research-based assignments. The test and examination are assessed summatively with feedback and comments on the test constituting formative assessment. Final examination will comprise of one 3 hour written externally moderated examination, which will contribute 50% towards the student's final mark.

#### Target Group

: The target group are students who are studying toward the LLB degree. The course is offered to 4th year LLB students and it deigned to equip learners who intend to pursue careers in the aviation and related sectors as legal advisers, legal practitioners, policy analysts, etc. It will also be beneficial to learners who intend to pursue postgraduate studies and research in the area of aviation law.

#### **LMU 423 E**

#### **Consumer Law**

#### **Purpose**

: The module is intended to be an introductory course covering the fundamental principles regulating the broad and diverse aspects of consumer law. It seeks to empower learners with knowledge of the content, interpretation and practical implications of the international and national rules regulating the consumer industry. It is designed to equip learners who intend to pursue careers in the consumer law industry as legal advisers, legal practitioners, policy analysts, etc. It will also be beneficial to learners who intend to pursue postgraduate studies in the areas of consumer law.

#### **Contents**

: The module will focus on various Acts; like the Consumer Protection Act, the National Credit Act, Community Schemes Ombud Service Act and will contrast with various provincial consumer Acts. The module will serve as an introduction to these Acts and will offers the learner a broad understanding of the protection of consumers in South Africa.

#### Teaching

Expository lectures, class presentations including public lectures by officials from consumer regulatory bodies; learning by doing (e.g. draft of legal opinions), research and writing of assignments.

#### Assessment:

Students are required to do all the assessments, both formative and summative. Students' group work and individual research-based assignments will be assessed. The test and examination are assessed summatively with feedback and comments on the test constituting formative assessment.
